

Notice (Incoterms 2020: DAP Beerse)

- The seller will give Aurubis Beerse timely written notice, at latest two working days before the delivery and propose a delivery date (receptie@aurubis.com), by means of:
 - the application form trucks + loading schedule (See Appendix 1)
- Aurubis Beerse has the right to change the delivery date proposed by the seller, insofar as Aurubis Beerse at the same time informs the seller of at least two other delivery dates
- Aurubis Beerse will confirm the delivery date by sending the seller an unloading appointment with unloading reference (See Appendix 2)
- At the time of the delivery the seller, via his transporter, must present the unloading reference to Aurubis Beerse
- If the material is from non-EU origin, the supplier needs to provide Aurubis Beerse a pro forma invoice and T1 document or a document IMA before unloading.

Capacity planning

- Aurubis Beerse plans the number of vehicles of raw materials to 70 per day
 - 60 vehicles with 1 batch
 - 10 vehicles with several batches

Loading

- The seller will preferably load the goods in bulk
- The maximum loaded weight (weight material + packaging; exclusive weight container) in:
 - 20' = 27500 kg
 - 40' = 21000 kg
- The seller will preferably deliver 1 batch per truck
- Trucks with several batches will be in compliance if:
 - A maximum of three batches have been loaded
 - The batches have been properly separated
 - The batches have been marked
 - The batches have been grouped and loaded in accordance with the loading schedule
- If the goods are packaged, Aurubis Beerse allows the following intact packaging:
- Plastic skids/packing are not allowed

Delivery

- Raw materials in bulk must always be delivered in tipping vehicles or walking floors
- Packaged material will preferably be delivered in tipping vehicles or covered vehicles, sea containers always on tipping chassis
- A truck will only be handled on the day confirmed on the unloading agreement. If the information regarding the unloading appointment changes, the seller must immediately inform Aurubis Beerse thereof
- In case no agreement is reached about the quality of the material, a reloading cost of 250€ will be charged
- PPE's (Personal Protective Equipment) for drivers:
 - Each driver is bound to wear the following equipment when entering the Aurubis Beerse territories:



- : safety helmet + safety glasses



- : fluo jacket



- : closed shoes

- We advise:



- : long trousers and long sleeves

- Drivers need to present themselves at our counters fully equipped.

Opening hours

- Deliveries will be effected between 06:00 hours and 17:00 hours. On the last working day of the month until 15.00 hours
- Trucks with several batches are obliged to report between 06:00 hours and 15:00 hours. On the last working day of the month until 12.00 hours

Non-compliance

- Every deviation from the above-mentioned instructions is deemed non-compliance
- Every non-compliance can result in waiting times for the transporter which cannot be at the expense of Aurubis Beerse
- In the event of non-compliance of the shipment, at the start of the unloading an operations fee of € 200 per started hour will apply



- In the event of non-compliance of the packaging, per packaging a fee of € 150 will be charged for handling and removal
